- When you have decided on the charter and date you want, and checked flight availability, please email or call (00 34) 660647845 to reserve your dates. Due to postage delays we cannot accept a telephone reservation unless accompanied by an emailed, signed booking form, with payment details. Flight details can be supplied later.
- Fill in the booking form and send with insurance company details by email or post to Menorca Cruising, Moll de Llevant 303, Puerto de Mahon, Menorca, 07701, Islas Baleares, Spain.
- I will immediately confirm your reservation, with joining instructions, clothing advice and balance of fees invoice, due 1 month in advance.
- To book a Bareboat Charter the Skipper must hold a minimum of an RYA Day Skipper sail qualification and he/she must apply to the RYA ([www.rya.org.uk](http://www.rya.org.uk)) for an International Certificate of Competence (ICC). A copy of this ICC or another appropriate qualification must be sent to MCS before or with the final payment.

## Booking terms and conditions

- YOUR CONTRACT is with LANIVICO SL trading as Menorca Cruising, hereinafter called MCS  
PROVISIONAL BOOKINGS will be accepted by email or telephone, but these must be accompanied by an email of the signed booking form. Your booking is only accepted by us when you receive our email confirmation.
- OUR PRICES - we guarantee not to increase our holiday prices once booked.
- HOW TO PAY - There is a 50% deposit with the signed booking form; balance payable no later than 4 weeks before commencement of course. Should you fail to pay, your holiday will be offered for resale. Final reminders will not be sent and your deposit will not be refunded. For holidays booked less than 4 weeks prior to commencement of course, the full fees are payable at the time of booking and confirmed by email.
- CANCELLATION BY YOU must be in writing and will be effective from the date received at our Menorca office. The deposit will be forfeited up to 4 weeks before commencement of the course and the full amount thereafter.
- CANCELLATION BY US - We reserve the right to cancel and refund all sums already paid, plus £20 compensation per person.
- INSURANCE - MCS will insure the yachts against all usual marine risks. This policy will not cover injury, loss of life or damage to or loss of the charterers property, against which the charterer must insure prior to the course.
- CARRIAGE - Thereinunder is subject to the rules and limitations relating to liability re- established by the Athens Convention, as enacted in "The Carriage of Passengers and their Baggage", by sea Domestic Carriage Order 1987.
- FORCE MAJEURE - Neither party shall be liable if prevented from fulfilling any of its obligations by an incident of Force Majeure including an act of God, strikes, lock out, government or any other occurrence beyond our/your control.
- In all cases the decision of the professional skipper is final.
- DISPUTES will be conducted under English law
